CXO BREAKFAST SERIES




CYBER MEETUPS

MD Cyber Meetup: A combination of casual networking and business, these our Cyber Meetups programs bring Maryland's cybersecurity community together 4-6 times per year and typically feature a quest speaker on a relevant cybersecurity or business topic. They provide face-to-face connection to educate. enlighten, create partnering opportunities, inspire referrals and provide introductions for funding or acquisition resources. Attendees include cybersecurity innovators, company executives and professionals; cybersecurity solution seekers and customers: investors: academic and training entity representatives; general service providers (e.g., legal, insurance, accounting, marketing, business coaching, sales training) and job seekers.
