



Maryland: Where Cyber Works - Cyber Job Fair – Spring 2019

Sponsorship Opportunities & Agreement

As its name suggests, this program is a job fair featuring opportunities for those seeking cybersecurity jobs in Maryland. In 2019, CAMI will host two job fairs with this Spring one targeting job seekers **with cybersecurity work experience**. It is designed specifically:

- **For Maryland employers** (businesses and government entities) to connect with skilled candidates for open cybersecurity career positions at all levels and to create awareness of funding programs and support resources to help them with their cybersecurity workforce needs
- **For Maryland academic and training entities** to connect with incumbent workers and employers who would benefit from their programs
- **For skilled job seekers** to connect with **Maryland** cybersecurity career opportunities as well as academic and training resources available to assist them in getting additional skills, training and certifications as may be required by jobs of interest
